



## **Margulies Perruzzi Architects Completes Office Design for Fiduciary Trust Company**

*Investment management firm renovates office space in namesake building*

**BOSTON, Mass. – April 21, 2009** – Margulies Perruzzi Architects (formerly Margulies & Associates), one of Boston's most innovative architectural and interior design firms, today announced that it has completed the design of 45,000 square feet of office space for Fiduciary Trust Company. Founded in 1885 as a family office and incorporated in 1928, Fiduciary Trust Company is an independent and privately owned wealth and investment management company providing services and advice to individuals, families and select charitable organizations.

"As investment managers and trustees with a proud tradition and a rich history in the city of Boston, our clients look to us for stability and sound financial advice, and we wanted our space to remain a place where clients were comfortable seeing us," said Bob Karelitz, Fiduciary Trust's general counsel, who led the lease renewal and renovation project. "Margulies Perruzzi Architects worked with us to create a classically designed space that reinforces our longevity in the investment business, while demonstrating our openness to new ideas."

Margulies Perruzzi Architects was selected to help Fiduciary Trust explore its real estate options as the company was weighing the pros and cons of finding new space or staying and renovating its existing office in the notable Fiduciary Trust Building at 175 Federal Street in downtown Boston. An original and primary tenant since the building was completed in 1977, Fiduciary occupied three and a half floors of inefficiently used space. Margulies Perruzzi Architects conducted several test fits in buildings around Boston to help Fiduciary consider its options for moving to a new location. Based on this process, Fiduciary decided to stay in its existing location and modernize its space in the uniquely angled building in Boston's financial center.

Completed in late 2008, Fiduciary's new office space incorporates hardwood and glass with a blue color palette. High-efficiency, indirect lighting was selected to provide an updated look, ease eyestrain of employees, and promote energy savings. An open staircase between the reception area and the floor above was re-designed in dark wood and glass to fit into the new design. The re-configured space features 93 workstations and 65 offices around the perimeter,

with the use of patterned glass on the sidelights of office doors to let in light while maintaining office privacy.

"Fiduciary Trust is a company that exudes timeless stability and responsibility, and it was important to portray those values in the design," said Janet Morra, AIA, LEED AP, principal at Margulies Perruzzi Architects. "The renovation marks an important point in the history of this company and the building, and we enjoyed working with Fiduciary to envision this new design for their office environment while maintaining the company's longstanding identity."

Commodore Construction was the general contractor for this project, and The Collaborative Engineers provided mechanical, electrical and plumbing engineering. Meredith & Grew served as the project manager.
